freedoms are basis of life of society in our country, and also a peculiar base for construction of the

constitutional state in the Russian Federation. But in practice we are often faced an ignorance of citizens'

rights and freedoms embodied in the country constitution, and, therefore, and the impossibility to

use and protect the rights. It is connected with the low level of legal culture in our country, and

also with the deformed consciousness and high level of legal nihilism, especially among youth.

The question of education of youth is always urgent. In this field many problems has accumulated.

Younger generation especially sharply reacts to propaganda of cruelty, violence and permissiveness, cult of comfort and consumption, social stratification and injustice and to many other

negative

phenomena.

The pseudo-culture through social networks, television, advertizing, sects, mystical cults, radical

pseudo-religions, a criminal milieu with its pseudo-romanticism and false pleasures, games, alcohol,

drugs and others "too available temptations" - all this has huge impact on a youth conduct of life now.

It leads to the fact that at the solution of the major vital questions - "Who am I?", "For what I live?",

"Who surrounds me?" "Who I want to become?", "Can you?" - the modern young man chooses usually

the simplest: to live for itself, to enjoy life. In outlook of yesterday's school students often there is no understanding of the law and legal canons, understanding of consciousness, along with philosophical

judgment of life, indistinct spiritual and moral value orientation.

And the ordinary student whether he understands the importance and focus of the stay in walls of

higher education institution. What is he focused on? It is important to have consciousness and to develop it.

It is obviously necessary to us to build the demanded platform for teachers and students where

education of youth is a priority task of society and state, and education of legal consciousness of students is the key moment in educational process.

The formation of the Russian National Guard is undoubted priority. Already on surveys of students

of our college many of them dream to get a due education and to join the ranks of fighters of

National Guard. As in consciousness of society the image of guardsmen as employees with boundless powers where Fighters of National Guard will keep public order, territorial defense of

We want to note that it is necessary to bring up younger generation so that to keep and increase

spiritual and moral traditions of Russia, to pay special attention to continuity of seniors, to increase

the level of consciousness at each .

And finishing my report, I want to say the words of the philosopher and publicist Dmitry Likhachev:

"There are light and darkness, there are a nobility and meanness, and there are a purity and dirt: it is necessary to grow to the first and whether to the second it is worth falling? - Choose worthy, but not easy!"
